## **Ewa by Gentry Community Association's Home Expo 2026**

This contract between the Ewa by Gentry Community Association (EbGCA) and the Exhibitor shall be for the day of June 6, 2026. Ewa by Gentry Community Association's Home Improvement & Maintenance Expo (Event) will be held at the Westside Community Center on Koana St. The term 'Exhibitor' will apply to all food vendors, businesses or commercial entities, and any other participants who will be dealing with Ewa by Gentry Community Association and the general public. The Event will be open to the public from 9:00 a.m. to 2:00 p.m.

Each Exhibitor must execute a contract for the right to exhibit. Subletting an exhibitor space is prohibited. Exhibitor space contracts will not be binding in the event of fire, strike, riot, civil commotion, natural disasters, acts of nature, war or other unavoidable circumstances which render the facility unfit for use, restrict limits or prevent the presentation of the Event. Exhibitors shall indemnify and hold harmless, EbGCA, its Board of Directors, staff, and its co-sponsors from all liability, which may ensue from any cause. EbGCA, its Board of Directors, staff and co-sponsors shall not be responsible for damages or otherwise to any exhibitor by reason of war, civil commotion, riot, fire, natural disasters, or occurrences, acts of nature or any causes beyond control which in any manner restricts, limits, or cancels the Event. The Event will be held, rain or shine.

Exhibitors shall be contained within their designated area or booth. Exhibitors shall not solicit or distribute handbills, brochures, or any other printed promotional material outside of their booth area. Interference with the light, space, or presentation of another Exhibitor will not be allowed. Placement of signs, banners, and/or advertising material shall be of good taste and Ewa by Gentry shall have the right to remove any material it deems offensive. Public address systems, sound, motion pictures or other demonstrations or equipment with objectionable light or noise as determined by Ewa by Gentry will not be permitted.

Exhibitors will be held responsible for any damage to the grounds, landscaping, facilities, equipment, or decorations caused or occasioned by them, their employees, agents, or representatives. Sprinkler systems must be protected against any damage or dangerous conditions. The storage of gasoline, kerosene, acetylene, or other flammable or explosive substances will not be permitted in the area due to a City ordinance. All decorative materials must be fireproof and must meet the requirements of the Honolulu Fire Department.

Exhibitors or professionals who are required by law to be licensed must hold a current license on file with the Contractors License Board (CLB). State law requires a firm offering installation work and/or offering contractual services on a job site as specified under CLB to be licensed. For assistance regarding licensing requirements, call CLB at 808-586-2700. All prospective exhibitors must provide, prior to the Event, evidence of a current license for the service exhibited where such services require a contractor's license under state law. Lacking such, Ewa by Gentry Community Association reserves the right to prohibit the Exhibitor from participating in the Event.

Exhibitors shall sell products which are legal and appropriate for a family, community-oriented event. Ewa by Gentry Community Association reserves the right to have an Exhibitor remove a product or item, which is objectionable to Ewa by Gentry Community Association or its designated representatives. The Exhibitor will not argue or question the request. Sales of guns or other weapons are prohibited.

Booth areas will be approximately 10' x 10'. Exhibitors may set up from 7:00 a.m. to 9:00 a.m. on June 6, 2026. All vehicles must be stationary and parked in designated location by 9:00 a.m. and set-up must be complete by 9:00 a.m. No unpacking or uncrating or packing and dismantling shall occur from 9:00 a.m. - 2:00 p.m. All exhibits must be completely dismantled and moved out by 4:00 p.m. on June 6, 2026. Exhibitors are responsible for disposing of all unnecessary boxes and trash and must clean their area at the close of the Event. Failure to comply may result in loss of deposit and refusal for booth space for future events. Any Exhibitor or Food Vendor NOT set up by official start of the Event will lose their deposit. Any food booth or Exhibitor who begins breaking down any time prior to 2:00 p.m. will lose their deposit and may be banned from participating in future events.

Cancellations are not excepted. Exhibitors who for any reason do not participate on June 6, 2026, are not entitled to a refund.

Exhibitors must comply with all City and County ordinances, State statutes, and Federal laws. Exhibitors will also comply with the rules of the Event as stated verbally or in writing by Ewa by Gentry Community Association. Failure to abide by the laws and this agreement shall be grounds for immediate removal or non-involvement in the Event.

Exhibitor understands that the Ewa by Gentry's Community Association's Home Improvement and Maintenance Expo 2026 event will be videotaped and photographed for the Ewa by Gentry social and print media and agree that myself and/or my workers/volunteers may appear on such.
